"The Open Spaces Society is committed to the protection of public rights over land. The society was delighted when the Supreme Court found in favour of Mr Day requiring that local authorities must be held to account when disposing of open space they hold on behalf of the public. The society stood up again when some peers sought to amend a Bill last year that would have removed this accountability. Such an amendment would have incentivised cash-strapped local authorities to feign ignorance when disposing of land they hold on trust for the benefit of the public. We commend Save Wimbledon Park for its ongoing efforts to uphold this important principle— public open space should not be allowed to be sold by public organisations on a whim."
